- **I. Welcome** Board President Jim Bell called the meeting to order at 6:31 pm.

 - Phil Tibi who has served on the ABEVA Board of Directors for 1 year and serves on the Finance Committee.
 - Will Hawking who has served on the ABEVA Board of Directors for about 1 year and serves on the Security Committee.
 - Michael Leeman who has served on the ABEVA Board of Directors for 2 years.
 - Steve Helm who has served on the ABEVA Board of Directors for a few months.

c. Approval of 2015 Annual Meeting Minutes – Mrs. Hawkins made a motion to accept the 2015 Annual Meeting Minutes as presented. The motion was seconded and carried unanimously.

II. Election Ballots – Nominations from the Floor

A call was made for nominations from the floor, hearing none the nominations were closed.

- **III. Arizona Biltmore Resort Update: Chintan Dadhich, Resort Manager** Mr. Dadhich spoke on behalf of the Resort and shared the following updates
 - \$35 million was spent on renovations
 - 450 rooms were renovated between 2012 and 2013
 - Roof and water leak/plumbing repairs have been completed
 - The conference center was renovated in 2015

- The Resort has worked with the owners of the Villas and renovations will be completed by those owners in the next 10 to 12 days.
- The restaurants have been renovated and new kitchen equipment was installed
- The main building will be renovated in 2016
- The Ocotillo building will be renovated in 2017
- **IV. Treasurers Report** The financials were provided to the owners present in the meeting packet. Jim Bell reported that the Board and management has been vigilant in keeping costs low. There has been no increase in assessments for 11 years. He also informed the homeowners that the annual review has been completed by Ginsburg & Dwaileebe CPAs and they can stop by the ABEVA office if they would like to review it.
- V. State of the Association Jim Bell reported that different projects had been completed to enhance the community. The street lights are in the process of being changed to LED. A 10-year road study had been completed and the first phase of the road improvement project has been completed. The next phase will be done in the summer of 2016.

VI. Election Results

CPA Mitzi Manka tallied the ballots received. Jim Bell announced the results of the election as follows:

 The property belongs to one of the sub-associations.
- Wash walkway maintenance is on-going
- Pet waste not being picked up. Need pet stations on Biltmore Estates Drive.
- Biltmore Lunch Bunch at Frank & Alberts La Rita Mason invited the ladies to join the group. The members' ages range from 30 to 85 years.
- Gatehouse built but never used It was built by the Resort to allow for PUD zoning should the Resort deiced to add on to the property.
