- I. Welcome Board President Jim Bell called the meeting to order at 6:30 pm.

 - Phil Tibi current Board Secretary who has served on the ABEVA Board of Directors for 3 year and serves on the Finance and Security Committees.
 - Will Hawking who has served on the ABEVA Board of Directors for about 3 year and serves on the Security Committee.
 - Michael Leeman who has served on the ABEVA Board of Directors for 4 years and serves on the Architectural and Employee Review Committees.
 - Steve Helm who has served on the ABEVA Board of Directors for 3 years and serves on the Security and Employee Review Committees.
 - Arnold Braasch who has served on the ABEVA Board of Directors for 2 years and serves on the Architectural and Election Committees.

c. Approval of 2017 Annual Meeting Minutes – A homeowner made a motion to accept the 2017 Annual Meeting Minutes as presented. The motion was seconded and carried unanimously.

II. Election Ballots – Nominations from the Floor

A call was made for nominations from the floor, hearing none the nominations were closed.

III. Arizona Biltmore Resort Update: Sheila Foley, General Manager – Ms. Foley spoke on behalf of the Resort and shared the following updates –

- A complete retrofit of the fire sprinkler system was completed
- Furniture was upgraded in the exterior public areas
- Renovations to the History and Mystery Rooms are upcoming
- The spa, pool and fitness facility renovations are on the books for 2019
- \$4 million dollars is spent annually on regular maintenance and smaller projects
- The Resort experienced record breaking revenue in 2017 and has had more than 6,000 more visitors in the month of January than the previous year
- **IV. Treasurers Report** The financials were provided to the owners present in the meeting packet. Ms. Shafkind reported that the budget is healthy and the bad debt ratio is less than 2%. The 2017 financials will be reviewed by the CPA in March.
 - V. State of the Association Jim Bell reported on the 2017 accomplishments.
 - The association received a settlement check from Cox Communications due to their lack of payment. He noted that Ms. Jones was responsible for discovering the oversight and bringing it to the Boards attention which resulted in the execution of a revised contract with Cox and regular payments being made going forward.
 - Landscape renovations were completed that were designed to save on water and improve the appearance of the community.
 - Road resurfacing is complete for the next four years.
 - Transcend is now using an electric car and a charging station was installed in the parking lot at the ABEVA office. This will save money on gas throughout the year and reduce the carbon footprint of the association.
