## FROM THE ABEVA OFFICE

#### **December 21st Board Meeting Highlights**

- Board President Harvey Shrednick called the meeting to order on December 21, 2009 at the ABEVA office and confirmed a guorum with 10 of the 11 directors present.
- The Open Homeowner Forum began. Pat Ventura of Colony Biltmore Greens presented a controlled access proposal for enhancing security along Biltmore Estates Drive that would require the Biltmore Estates Drive residents to form an HOA. Jay Glaser, Michael Kesselman and Steve Goldston, all of Colony Biltmore Greens, reiterated their concerns about the Thunderbird Trail guardhouse and said that their community was proceeding with an impact study, as two prior meetings with Biltmore Estates Drive homeowners did not result in a mutually acceptable agreement. The representatives also noted that there were differences between the guardhouse plans that were provided to ABEVA and those that were submitted to the city.
- Treasurer Stephen Hoffman presented the November 2009 financial reports and said that ABEVA indeed ended the last fiscal year under budget. Delinquent dues were running higher than usual, with 158 homeowners still having unpaid dues.
- During her Executive Director's Report, Roberta Peterson said ABEVA will soon be purchasing the vehicle used by Roving Patrol. She and Director Jay Swart will work together to get three bids, which will be presented at the January board meeting. The board also asked Ms. Peterson to write a letter to the resort to ask that they improve the appearance of their sign at the entrance on Arizona Biltmore Circle at 24th St. Ms. Peterson asked for direction on how to share homeowner complaints with the board. If she is uncertain about a particular complaint, she will contact the board President or Vice President. If the matter involves security, the complaint will be sent to the Security Committee members. Finally, Ms. Peterson reported that LVA Urban Design Studio will install new Thunderbird Trail walking path signs in January.
- Jay Swart, Security Committee Chairman, reported that the home invasion burglars in Paradise Valley have been caught. These people all had criminal records, worked in construction, and actually worked in the homes that they later robbed.
- With regard to the condition of the Colony Biltmore IV tennis courts, Marcia Finberg reported that she spoke with Corey Wells, the community's property manager. She will follow up to make sure that their board has correct information about ABEVA's position on getting the courts fixed.
- Stephen Hoffman reported that Taliverde will cut back their oleanders beginning on January 4th.

#### Update on Thunderbird Trail

The Arizona Biltmore Resort and Spa is considering the placement of a "greeter facility" to be located on Thunderbird Trail. This would include the construction of a small guardhouse on the center median and the installation of a closed circuit camera system to monitor the northbound and southbound lanes of Thunderbird Trail.

The resort has responsibility for the maintenance of Thunderbird Trail and the right to construct and maintain any improvements. However, the resort has entered into a recent agreement with a group of individual homeowners ("BCIC"), and has delegated the responsibility for the operation, maintenance, repair and replacement of the camera system to this group. At this time, it is not clear how this camera system is intended to be monitored or how liability issues will be addressed.

BCIC is a corporation comprised primarily of loop road homeowners who have expressed concern over the lack of security within the Biltmore Estates, particularly for the homes along the loop road and Thunderbird Trail. In accordance with their agreement with the resort, BCIC will be responsible for engaging the services of a licensed and insured camera system provider for the ongoing operation and maintenance of the camera system, as well as the storage of the information captured by the camera system.

The resort will be funding the construction of the greeter facility and the installation of the camera system, as well as assuming responsibility for the greeter. The resort's agreement with BCIC clearly states that the greeter "shall be obligated only to direct vehicular and pedestrian traffic and to provide information upon request to users of Thunderbird Trail. The greeter shall have no obligation to act as a security guard..."

The resort expects to begin construction on the greeter facility around March of 2010. ABEVA has not objected to the concept of a greeter facility, but has raised concerns as to its location and the impact on neighboring associations (Colony Biltmore, Greens and Taliverde). The resort is not attempting to restrict traffic flow; however, long-time residents remember a previous attempt to install a greeter facility which resulted in the abandoned structure, still standing, just east of 24th Street.

ABEVA has been invited to join in the funding of the camera system, but has thus far declined. The question has been raised as to whether these security cameras would be of sufficient benefit to all ABEVA members to justify the use of ABEVA funds.









Under the 1983 Agreement, which covers the common area roadways, ABEVA and the resort share ownership of Thunderbird Trail. Although the Agreement is lengthy, there are three key provisions relating to Thunderbird Trail:

1.) The Resort "shall have the sole responsibility for the maintenance of and improvements of any type" on Thunderbird Trail.

2.) The Resort has the right to "alter the appearance and design thereof, regulate pedestrian and vehicular traffic thereon and to provide and regulate parking thereon..."

3.) The Resort shall not take any action "that does not preserve reasonable access in a manner that promotes the safety and welfare of the Members of ABEVA and the guests, invitees, agents and the employees of ABH (the resort) and protects the value, desirability and attractiveness of the Covered Property and the Benefited Property."

ABEVA represents 1,688 homeowners located within the Arizona Biltmore Estates and the Board members are aware that there are conflicting opinions on this issue. Please let the Board know your thoughts by emailing Roberta at rpeterson@abeva.com.

#### **Annual Meeting**

#### **Just One Single Vote**

Think your vote doesn't count? Your vote can make a difference in the outcome of elections at local, state and federal levels.

- The states of California (1850), Idaho (1890), Oregon (1859), Texas (1845 and Washington (1889) were all admitted to the union by just one single vote.
- In 1962, the governors of Maine, Rhode Island and North Dakota were all elected by a margin of just one single vote.
- The Alaskan Purchase of 1867 where we purchased the whole state of Alaska was ratified by just one single vote.
- In 1776, the official language of America became English instead of German by just one single vote. (The deciding vote was cast by the son of a German immigrant.)
- Thomas Jefferson was elected President of the United States in 1800 by just one single Electoral College vote.
- Right here in Arizona, former State Representative



Richard Kyl actually tied in his election for the State House of Representatives. After three separate recounts came out tied, the winner was determined by a simple card game of "highest card." Kyl picked a 3 and his opponent picked a 2. Note: the opponent's wife had forgotten to vote on Election Day, so that one single vote could have changed the outcome.

- In the 1960 presidential election, John F. Kennedy's margin of victory over Richard Nixon was less than one vote per precinct in four states (Illinois, Missouri, New Jersey and Texas).
- And finally, in 1923 members of an obscure new political party met in a Munich beer hall and elected ex-soldier Adolph Hitler to be leader of the Nazi Party, by just one single vote.

These are powerful examples of what many people view as an old cliché. The power of voting is real. Our country, founded on the principles of democracy, now stands as a world leader, a true superpower. You can have a say in how our nation (or your HOA) is governed.

Hi All, My name is Officer Jon McLachlan, and I work for the City of Phoenix Police Department and have worked this area for a little over eight years. Due to the recent burglaries in the Biltmore area, I would like to take this opporcrime prevention tips

tunity to provide a few crime prevention tips.

Burglars come in a wide variety, and the majority of them are "amateurs." The amateurs are "opportunists" who are looking for easy targets and will perform burglaries when the opportunity presents itself. Most opportunities are unlocked doors, open windows and garages. A burglar can and will knock on the door of your house to see if anybody is home and will strike if there is no answer at the door. If you open the door the burglar may either act as a solicitor, or simply pretend to be looking for a friend. Please do not answer the door for solicitors. Tell them through the door that you are busy or not interested. Burglars will do many different things when they are "casing" houses. They will check doors to see if they are unlocked, see if the house is alarmed, gates are unlocked or are easily accessible. Most burglaries occur in the rear of residences as they are less visible to neighbors.









What can neighbors do? Call the police when you see suspicious people or activities in your neighborhood. (If possible, take photos and license numbers.) You know your neighborhood better then we do, you know who belongs and who doesn't. We are not asking you to confront potential burglars or suspicious people. With the weather getting nicer, we are all turning off air conditioners and opening up windows and doors. When you leave, even for a trip to the store, check to make sure your house is as secure as it can be. Lock all doors and windows and use your alarm system if you have one. Check to make sure your garage shuts completely before you pull away or when you enter the house.

When you are going to be out of town, have someone whom you trust check on your house regularly. Have them pick up newspapers and flyers from solicitors. Set lights to timers to come on at different times of the day and call into the Squaw Peak Precinct to have your house put on a vacation watch 602-495-5007.

While out shopping at the malls and stores, please be aware of your surroundings and locations where you may park. Try to park in well-lit areas and, if you feel uneasy, move to a different area. Please keep all valuable items out of view in vehicles. Your valuables are protected by nothing more then a piece of glass! Keep an eye on purses while shopping, and please don't fight someone attempting to take your items. Nothing is more important than your safety.

#### Monthly Patrol Recap

The ABEVA Roving Patrol, the community's eyes and ears, operates 24/7 throughout the entire community. For November, the patrol reported 238 calls or incidents.

These included: alarm calls 28; assaults 0; burglaries 2; suspicious persons 10; vehicle trespass 8; disturbances 15; miscellaneous 36; neighbor disturbance 12; fire truck on site 18; medical emergency/ambulance 14; property damage 0; police involved 18; process servers 0; sleeping guards 0; property theft 2; theft/vehicle 0; pool backwashing 1; traffic/parking violations 36; water/gas leaks 15; window/gate open 12; garage doors open 36; pool gates open 3.

For the fiscal year, they drove a total of 66,407 miles.


