Annual Assessment for ABEVA

ABEVA is the Master Association and has an annual assessment. The 2010/2011 annual assessment invoices will be mailed out by September 30th and will be due November 1st. The budget committee has completed their review, and formal adoption by the board will occur at the September 20th Board of Directors meeting.

Delinquent Owners

As of August 25th, 32 owners remain delinquent in their annual dues to ABEVA from the 2009/2010 annual assessment. Thirteen of the 32 owe late and/or legal fees, which will again be billed with the fall invoice. Several are pending trustee sales or bankruptcy. The remaining are currently bank owned.

ABEVA General Information

OVERVIEW:

Arizona Biltmore Estates Village Association (ABEVA) is the master homeowners association for all residential properties and certain commercial properties located in the Biltmore area. The boundaries are 24th St. to 32nd St. and Camelback Rd. to Lincoln Dr. ABEVA is a non-profit corporation, which was formed in June of 1979. There are 17 individual residential communities and one apartment community, each of which have their own subassociations and are managed by professional firms. The new condo and town home sub-divisions along Camino Acequia are required to pay ABEVA dues and be subject to ABEVA architectural guidelines; however they will not be voting members of ABEVA.

Commercial properties include the Arizona Biltmore Resort and several office complexes located along Arizona Biltmore Circle and 24th Street. ABEVA provides limited common area services for these properties such as lighting, street sweeping and pavement maintenance.

GOVERNANCE AND MANAGEMENT:

ABEVA is governed by 11 directors elected by the members of the Association, who comprise the residential homeowners. Current officers are the President - James Bell, Vice President - Heather Litton, Treasurer - Stephen Hoffman and Secretary - Marcia Finberg. The Executive Director, Roberta Peterson, and the Administrative Assistant, Beryl Ross, provide day-to-day management.

FUNCTION AND SERVICES:

ABEVA provides landscaping and paving maintenance for common areas located outside the various individual communities except for Thunderbird Trail from 24th Street to the resort entrance, which is the responsibility of the resort.

A twenty-four hour roving patrol covering all areas including individual communities is provided. This service is currently under contract with Securitas.

ABEVA installed and maintains 71 lights on the common area roadways.

Architectural and landscape control for all areas outside the individual communities is the responsibility of the Architectural and Landscape Committees through the Board of Directors.

ABEVA is responsible for the enforcement of the rules and regulations established pursuant to provisions contained in the Declaration of Covenants, Conditions and Restrictions.

There are 33 "grandfathered" properties located on Thunderbird Trail and Biltmore Estates Drive that are exempt from control by ABEVA. Many of these homeowners make an annual voluntary contribution of dues, and ABEVA includes all 33 in services provided.

FINANCES:

The primary source of revenue is annual assessments from each of the 1,688 residential homeowners. annual assessment is paid in advance at the beginning of each fiscal year. For the past 5 years the rate has been \$275, which covers operating expenses and additions to the reserve fund for future major repairs and capital In addition, ABEVA receives annual improvements. assessments from the Geneva Holdings Condominiums and approximately \$55,000 from various commercial properties to cover the cost of maintaining the roadways north of the canal.

The operating budgets are prepared annually, by the Executive Director, as the basis for establishing annual assessment rates. The budget is reviewed by the Budget Committee of the board, and then it is approved by the full board. Approval from the homeowners is not required.

Attempted Break-In

ABEVA reports one attempted break-in, on August 18th.















This incident occurred in Taliverde. The house is the first house inside the walking gate off Camino Acequia. The owners, a husband and wife, left about 2:00 p.m. A would-be robber broke through the gate near



the front of the house. He then broke the front door lock. However, there was one person still inside the house, a grown son who was visiting. When the robber saw him, he fled. There was some concern surrounding an air conditioning company that was working next door. Although police questioned them, they concluded it was more likely that this was a crime of opportunity, with the suspect jumping the gate.

As always, we warn homeowners to be vigilant and not be lulled into a false sense of security if you reside in a gated community.
