About 175-200 owners were in attendance at the annual meeting.

Jerry Colangelo

Jerry Colangelo, Partner in JDM was the first speaker. JDM now owns the Arizona Biltmore Country Club and the Wigwam Resort. Jerry's partners are Mel Schultz and David Eaton. Their business strategy is to find distressed properties with a positive cash flow. The Arizona Biltmore Country Club and the Wigwam Resort, both iconic assets, fit their parameters. JDM bid competitively on the properties about 18 months ago.

The partnership first focused on the Wigwam. They renovated the entry lobby, and food and beverage areas. Now the partnership is focused on the Biltmore golf course. Mr. Colangelo emphasized that not only does he believe that the hotel and golf course should never have been separated, he also believes that there is now and always

will be synergy between the two entities. JDM is therefore considering different plans to enhance the property. They want to improve the appearance of the Adobe Restaurant and are deciding whether the best strategy is to refurbish or tear down. They are considering menu additions, possibly adding dinner and/or home delivery. JDM does not want to compete with the hotel. They may survey homeowners to determine preferences.

Mr. Colangelo emphasized that he and his partners are enthusiastic about the Biltmore community. In fact, they moved their office to 2400 Arizona Biltmore Circle. Homeowners should be assured that they plan to make the golf course a community asset.

Andrew Stegen

Andrew Stegen, General Manager of the Resort, opened his remarks lightheartedly by noting that happy hour prices at Frank and Albert's will continue through the spring. He continued by stating that business is good; the Resort is currently about 97% occupied. Mr. Stegen echoed Mr. Colangelo's statement that synergy between the golf course and the resort was crucial, and he expressed pleasure that JDM is the new owner of the golf course.

Mr. Stegen allayed homeowner fears about the Chapter 11 filing by the new owners of the Resort. He explained that the Chapter 11 bankruptcy was done to reorganize and reduce the debt. Cash flow in the property is positive. There is no danger that the doors will close. He added that since Phoenix is becoming a top tier convention destination, he expects growth to continue.

Over the past two years, over \$30 million has been put into the property. All of the ballrooms have been renovated, Frank and Albert's was added, and many other projects were completed. He again stressed that the Resort is cash-positive.

There was a question with regard to the repaving of Thunderbird Trail. Mr. Stegen stated that this will be a priority in 2012. In the meantime, the landscapers will help to keep the road passable. A homeowner suggested that rubberized asphalt be considered when the road is repaved.















Treasurers Report

Stephen Hoffman stated that ABEVA is on target with the Reserve Study in good financial shape.

President's Report


Mr. Bell reported on the following:

- Homeowners are kept informed about the business of the Association through the ABEVA Brief newsletter.
- Endorsement of Roving Patrol: The Roving Patrol responded to 6,232 calls in the past year. Calls included alarms, burglaries and robberies, suspicious persons, disturbances, emergency vehicles, property damage, property theft, vehicle theft, water leaks, open windows and garage doors, and open pool gates. Over 1,000 calls were for open garage doors during the night.
- ABEVA maintains ongoing relationships with the Resort, Golf Club, Fashion Park, Wrigley Mansion and Condo Developer.
- ABEVA keeps abreast of zoning issues via a Board Member, Jay Swart, who serves as Chair of the Camelback East Village Planning Committee (CEVPC).
- ABEVA is a member of Community Association Institute (CAI) which is a national organization dedicated to fostering vibrant, competent, harmonious community associations. This organization monitors all current legislation and trends. There are currently 15 bills before the legislature which could affect HOAs. The ABEVA Executive Director takes an active part working with the legislature.
- ABEVA was nominated and won a Certificate of Appreciation from the Police Department for being a caring community. ABEVA maintains an ongoing relationship with Officer Ben Carro from the Squaw Peak Police Department Neighborhood Enforcement team.
- ABEVA has an active Security Committee which is chaired by Jay Swart.

Security Report

Chairman Jay Swart stated that the Security Committee has done an aggressive and extensive review of security issues and concerns. The committee developed and implemented plans to enhance safety. Patrol techniques have been improved. Patrol staff was upgraded; most staff members now have law enforcement or military backgrounds.

Jay then introduced the ABEVA Emergency Guide. The laminated guide was developed as a go-to source for information about how to handle emergencies such as fire, poisoning and burglary. The guide also features necessary phone numbers, including the number for the ABEVA Roving Patrol,



All homeowners in attendance received a copy. The guide has been distributed to most other homeowners. Residents on the Loop Road, Meridian, Courts II/Vistas and Villas II should stop by the ABEVA office for their copies. Homeowners are encouraged to keep the guide in a handy and visible place and refer to it often.
