Highlights from the April 25th Board of Directors Meeting

- The April 25th meeting was called to order by President Jim Bell. Treasurer Steve Goldston reported that financials are in good shape. If expenditures continue on the same path, ABEVA should come in under budget.
- Steve Goldston also reported on Geneva Holdings. There are units now in use as rentals. ABEVA has sent a letter to Geneva Holdings requesting dues owed. The Board decided that we have an obligation to try to get the money owed us, so the Board voted to take legal action.
- Jay Swart reported that the project at 26th St. and Camelback will be discussed at the next meeting of the Camelback East Village Planning Committee.
- The Board approved several road and light repairs.
- The Board will respond to a letter from Biltmore Square Homeowners, thanking them for sharing concerns and further thanking them for their expression of strong support for ABEVA's work.

Monument

You may have noticed the destroyed monument and sign in the island where Biltmore Estates Drive and Thunderbird Trail meet. This occurred during an event



held through the Golf Club in the median on Thunderbird Trail. The repair process has begun. Biltmore Block must be specially ordered. The process takes two months. Therefore, we ask that homeowners have patience. The repairs will be paid for by the party company that hit it.

A homeowner complained about nearby construction beginning too early in the morning. Unless otherwise restricted within your community – the City of Phoenix Nuisances and Noise

Ordinance states that construction hours should be weekdays between the hours of 6:00 a.m. and 7:00 p.m. from May 1st through September 30th and between the hours of 7:00 a.m. and 7:00 p.m. October 1st through April 30th. If you hire contractors, please make sure your contractors are considerate of your neighbors.

ABEVA Finances

As you know, the annual assessments to ABEVA were due on November 1st of 2010. As of April 18th we have 55 delinquent owners. Of those, 21 owe late fees which will remain on the accounts and appear on each month's financial reports. The remainder is delinquent for various reasons including pending trustee sales, bankruptcies, short sales or they are just ignoring our collection attempts. The balance of workable accounts has been turned over to the association attorney for collection.

Over the last couple of years, residents have been complaining about over aggressive door-to-door solicitors, as well as solicitors whom they believe were actually casing neighborhoods for burglaries. Although there are cases to support both claims, the majority of solicitation is legitimate. The problem is how do you differentiate between legitimate and illegitimate solicitation? The answer to this question is difficult, being that anyone can put on a friendly face. However, the Phoenix City Council has heard from the community and has passed a solicitation law which should help restrict the criminals posing as solicitors in neighborhoods. The new ordinance will restrict commercial solicitation in the following way:

From April 1st through September 30th, solicitors will not be allowed to knock on doors from 9 p.m. to 9 a.m. From October 1st to March 31st, the time will change to 7 p.m. to 9 a.m. Solicitors 15 years old and older will be required to carry and display upon request a government-issued ID (this includes a school ID for those 15 years old). Upon request by a resident, solicitors must provide ID. Upon request by a resident, solicitors (or anyone for that matter) must leave the property. This also applies if a "No Trespassing" or "No Soliciting" sign is posted in a place where anyone coming onto the property can see it. When a "No Trespassing" or "No Soliciting" sign is posted, solicitors are not allowed to touch windows or pass through a closed gate to enter the property. Solicitors are prohibited from claiming that they have a government-issued business license, a regulatory license, or a tax license. All handbills must be placed in a clearly marked box or other receptacle used for handbills.

Violators of the solicitation ordinance may be charged criminally as a misdemeanor. Upon conviction, violators potentially could face six months in jail and ordered to pay up to \$2,500 in fines. Businesses convicted could face up to \$25,000 in fines. Above all, it is good advice not to open your door to anyone you don't know or weren't expecting, such as a repairperson.

Biltmore Area Partnership Lunch


