Highlights from the May Board of Directors Meeting

- The meeting was called to order at 5:30 pm by Marcia Finberg, ABEVA Secretary. Treasurer Steve Goldston explained that ABEVA's funds are in good shape. In order to maximize the yield in our Reserve Account, additional CDs have been purchased and laddered in place of money market funds. The operations budget is also in good shape. Accounts Receivable continues to improve. Last month there was one big expense, a street light repair, which was covered under ABEVA's insurance.
- Geneva Holdings paid 2010-2011 dues and late fees for their owned units at Fairway Lodge. The Board voted to approve the financials. Vice President Mark Monseraz continued the meeting.
- Jay Swartz discussed the CEVPC meeting. The controversial planned apartment complex at 26th St. and Camelback was the key item of their agenda. Jay reported that neighbors have mounted two legal actions, asking the city to re-review the project approval.
- Jay also reported a security success. Police were able to arrest the three people responsible for a recent rash of car burglaries. The Security Committee is delighted to report that since these arrests, car burglaries have stopped.
- The final agenda item was in Old Business. The Board agreed that we should ask for bids from four landscape contractors. In the RFP, we will provide ABC Scapes contract redacted to delete all numbers, so we can get parallel bids from all.
- The meeting was adjourned at 6:25 pm.

Legislative Update

On April 20th 2011, the First Regular Session of the 50th Arizona Legislature came to a conclusion. There were 1,350 bills introduced, of which 386 passed, and only a small number were vetoed by the Governor.

On behalf of HOA legislation, 146 bills were introduced with only a small number passing. Once the

association attorney has his summary of these completed, a copy will be placed on the website. The very short "cliff notes" version is:

- HB2245 allows audio and video taping of meetings;
- HB2609 additional rules to open meetings and signage;
- SB1148 attempted resurrection of the Administrate Law Judge;
- SB1149 Document Fees; Real Estate Signs Requests from Title Companies need to be turned around in 10 instead of 15 days and Transfer and Disclosure Fees cannot exceed \$400. Communities can no longer force owners to use special For Sale/For Rent signs or prohibit riders:
- SB1326 Flag Displays The Gadsden Flag has been added to the list of allowed flags, however associations can limit the number of flag to no more than 2.
- SB1540 1st it is a class 2 misdemeanor to knowingly remove or alter or deface any political sign;
 2nd Association cannot prohibit door to door political activity (with exceptions) and 3rd the law expands the timeframe for which these signs are protected. (SB=Senate Bill & HB=House Bill)









Thieves in the Waste Basket

Most—but not all—identity theft now occurs electronically. But your identity can still be easily scored by thieves who make use of what you toss in your waste basket, too.





Beware also of those bothersome credit offers you get in the mail and toss them unopened into the trash—particularly the pre-approved variety. Clever scammers complete these blank applications, obtain a credit card in your name, charge it to the limit and close the account before you receive the first billing statement. To protect yourself, all you have to do is tear the unopened envelope in half once or twice before tossing it in the waste basket.

Better yet, you can eliminate these prescreened credit offers from your mailbox by calling 1-888-5-OPT-OUT (1-888-567-8688) to opt out. You'll be asked to provide your Social Security number so the consumer reporting companies can match you with your file.

Also, deposit your outgoing mail containing personally identifying information in post office collection boxes or at your local post office, rather than in an unsecured mailbox. Promptly remove mail from your mailbox. If you're planning to be away from home and can't pick up your mail, contact the U.S. Postal Service at 1-800-275-8777 or online at www.usps.gov to request a vacation hold. The Postal Service will hold your mail at your local post office until you can pick it up or are home to receive it.
