## FROM THE ABEVA OFFICE Annual ABEVA Meeting

To find the Aztec Room, enter the main hotel entrance. The Aztec Room will be to your left. Sign-in begins at 6:00 p.m.

#### Highlights of the January 16, 2012 Board of Directors Meeting

- Thunderbird Trail The board was informed of a letter from a Fairway Lodge owner under the impression that the maintenance of Thunderbird Trail was ABEVA's responsibility. Thunderbird Trail is actually part of Parcel 20 held in Trust by Chicago Title and Trust with the resort and ABEVA as beneficiaries. Then, by separate agreement the resort is responsible for Thunderbird Trail and ABEVA for the remainder of Parcel 20 aka Biltmore Estates Drive. We have been advised that the resort is awaiting approval of its 2012 budget which includes these repairs.
- **Bylaws** The Board voted to amend page 8, Section 6.2 Number and Qualifications of Directors by eliminating 2 sentences that require owners live in the property they own. In other words, all homeowners who are members in good standing of ABEVA are now eligible to serve on the Board, regardless of where their principal residence is.

The section now reads: The number of Directors of the Association shall not be less than three (3) or more than fifteen (15) as determined by the Board of Directors. If the number of Directors is reduced, all Directors whose terms have not yet expired and who are in good standing shall be allowed to serve the balance of their terms. All Directors must be members in good standing of the Association in accordance with the provisions of Section 4.3. If a Director shall fail to meet the qualifications of good standing or membership at any time during his terms, he will therefore cease to be a Director and his place on the board of Directors shall be deemed vacant.

- The board was informed that the car used for two years by the roving patrol had 130,000 miles on it. Subsequently, the board learned that the car needed over \$3,000 in repairs. Board members were polled, and the board approved the purchase of a new car.
- Treasurer Steve Goldston reported that Geneva Holdings owes ABEVA about \$5,000 in back dues for 13 units that are currently rented. Back dues will be

paid as units are sold. Steve continued that the rest of the budget is where it should be. In addition, tax returns have been prepared and filed. As usual, ABEVA is in good shape financially.

- Jay Swart has worked with the city to require that the Arizona Biltmore Resort honors their commitment to stage trucks delivering supplies to the hotel off Arizona Biltmore Circle (a safety hazard) and onto hotel property. Part of the plan included posting explicit signs directing truck drivers where to park. Jay reported that these signs have not all been posted. There have been four incidents in the last few weeks. Jay is once again talking to the city and also to the Director of Security at the hotel.
- Questions have been raised regarding the maintenance of the rear walls facing the golf course. Many need to be painted, some need major repairs. These are the property and therefore the responsibility of the individual homeowners.
- The Board voted not to contribute to CAI, a lobbying organization for homeowners associations. Several Board members felt that the lobbying efforts were antihomeowner and therefore did not deserve our support.

#### **Your Personal Safety**

Taliverde resident Nancy Landry wrote a letter to the ABEVA Board detailing a chilling incident where pedestrians strolling in the middle of Biltmore Estates Drive almost caused an accident. Nancy asked us to remind all homeowners that the safest place to walk is on the sidewalk. Regardless, walk towards traffic. If you are with a large group, please be conscious of your safety and the safety of others. Board members noted that there have been difficulties with passing bicyclists, both in large groups and also riding individually.

Please use common sense. Walk on the sidewalks. Ride close to the curb. You may, in fact, have the right of way, but you don't want to be dead, right?

#### **Criminal Incidents**

There have been two serious criminal incidents in recent months. In one, a homeowner on Biltmore Estates Drive was held at gunpoint by two individuals wearing











masks. A number of items were taken but the homeowner was not harmed.

In a second incident, an individual broke into a home on Biltmore Estates Drive, stole some personal property and then exited. In this case, the homeowner was not home and their alarm was activated. Police theorized that because of the alarm, the burglar spent less time in the house and took fewer items.

We live in a generally safe area, but homeowners must exercise vigilance. Lock doors. Set your burglar alarm. Light your yard, ideally with motion detector lights. Do not be lulled into a false sense of security if you live in a gated community. Criminals have jumped over walls. Many know gate codes.

#### From ABEVA's Landscaper

#### 5 tips for treating frost damage

- 1. Non-indigenous plants and trees are highly susceptible to frost. When possible, choose native plants for your yard.
- 2. Frost is most likely to occur on calm, clear nights from November through February.
- 3. Water plants evenly in mid-morning (around 9:00 a.m. or 10:00 a.m.), if frost is predicted for overnight.
- 4. Before sunset, cover frost-sensitive plants with a porous cover such as burlap or a special frost covering fabric found at hardware stores.
- If you end up with frost damage anyway, don't prune away the dead foliage until after the threat of frost is gone (usually after February 15th) or new growth starts in the spring.
