

Grand Paseo / Lincoln Tunnel

ABEVA's attorney has sent a letter to the City of Phoenix Attorney requesting Phoenix reinstate the USE AND LICENSE AGREEMENT a recorded easement for the Grand Paseo that Biltmore Mountain Estates Owners Association ("Biltmore Mountain") and the Biltmore Hillside Villas Owners Associations ("Biltmore Hillside") had terminated. Biltmore Mountain and Biltmore Hillside had no legal right to a "Mutual Termination" of the use agreement. ABEVA hopes to resolve the access issue once and for all. Annual ABEVA Meeting

Mark your calendars! The annual meeting of ABEVA members will be held Thursday, February 13th, 2019 at 6:30 p.m. at the Arizona Biltmore Resort & Spa. Although that may sound far away, it really is not. The function of ABEVA is to govern common areas and address issues that affect the community as a whole. This year, there are 3 seats up for a vote. Each Director must meet the following criteria:

- 1.) He or she must be a member in good standing of ABEVA.
- 2.) Must be the owner of record of an ABEVA property.

Board meetings are held on the third Monday of each month at 5:30 p.m. in the ABEVA office. Meetings require a commitment of at least two hours at each meeting plus possible additional time to serve on committees.

If you are considering running for the board, we ask that you take a few moments to ask yourself the following three questions:

Do I have the time?

As a board member, you will need to devote several hours of your time each month to association business. In addition to regular monthly board meetings, you will need to be active in email discussions and occasional special meetings. During special projects, you may need to spend a little extra time on association business. Some board members may also spend a little more time than others if they work with a committee.

Can I make tough decisions when it's required?

The primary role of the board is to conduct the business of the association. This doesn't just mean approving the budget, but also developing and enforcing policies. Board members are required to step outside their immediate circles of family and neighbors and make decisions based on the greater good of the community.

Can I represent ABEVA in and to the larger community?

Our community is only as good as we make it. It is important for Board members to attend social functions and events in order to foster ABEVA's connection with our homeowners and with our neighbors. If you are interested in running for a seat on the ABEVA board, please submit a biography of 200 words or less that will be sent out with the ballots. You may mail it to the office or e-mail it to cjones@abeva.com. Be sure to include your full name, address, phone number and email with any correspondence. Annual Assessments for ABEVA

ABEVA is the master association and has an ANNUAL assessment this fiscal year of \$275. Any payment received after November 30th is considered late and will be charged a late fee of \$27.50. Late fees will not be waived. It is the homeowner's responsibility to pay his or her assessment in a timely manner. There is no requirement that an invoice be sent to ABEVA members. (Article III of the ABEVA CC&Rs). ABEVA sends these as a courtesy and reminder to homeowners. ABEVA cannot be held liable for mail delivery. If you have not paid your annual assessment please contact the ABEVA office immediately to make payment arrangements.















Summary of ABEVA Collection Policy

- Assessment (First Notice) is mailed out by October 1st, Assessment payment is considered late if postmarked after November 30th
- 2. Late fees of 10% (\$27.50) applied 1st workday in December
- 3. Late (Second) Notice is sent second week in December
- 4. Demand (Third) Notice is sent 1st week of February
- **5.** Account sent to attorney if no payment or arrangements are made by 1st week in March
- 6. Letter sent from attorney; additional \$250
- 7. Property is liened after 10 days; additional \$250
- Judgment is pursued, secured and recorded; additional \$650 to \$750
- **9.** Attempt is made to collect on judgment.

Dogs at Large and Trespassing By Officer Ben Carro

As the Community Action Officer assigned to your area, I would like share some thoughts on two laws that are commonly violated in the Biltmore. The first being dog at large violations and the second is criminal trespassing. A dog at large is currently a city code violation under P.C.C. 8-14 and trespassing, as it relates to real property, is a state code,



ARS 13-1502A. In each of these cases as it relates to the Biltmore community, I believe these laws are often violated. I do not believe in all cases the violator is intentionally or knowingly violating either law. For this reason, I am reaching out to the

entire Biltmore community in hopes of educating the residents and obtaining voluntary compliance. It is my goal to work together towards making the Biltmore a safer

my goal to work together towards making the Biltmore a safer community for all to enjoy. I am asking for your assistance in educating the members of the community who be aware of these laws. Through education, I am hopeful we can gain compliance with these issues which will result in maintaining your safety and your security within the community.

Please be warned that ABEVA has been notified by the golf course that the Phoenix Police will be patrolling the golf course, the resort and other ABEVA common areas and will be issuing citations for violators of the previously mentioned laws.


