ABEVA Annual Statement

You should have received your ABEVA Annual Statement, if not please contact the ABEVA office to correct your mailing address.

To meet the Association's financial obligations, the annual assessment is \$275 and is due November 1st, 2018. Through careful forecasting and budgeting of expenses, the Board of Directors was able to maintain the prior year's assessment without an increase. This will be the 15th year with no increase in the annual dues. It is possible that your amount due could be different if you have a credit or a past due balance. Please check "TOTAL DUE" on your statement in order to ensure you are paying the correct amount.

There are three ways to make a payment:

1. Mail in Payment: The enclosed invoice has a perforated tear-off portion that is to be returned with your check to ensure that your payment is appropriately applied to your account Please continue to make checks payable to ABEVA. Please put your ABEVA account number in the memo portion of your check to help ensure that your payment is applied to the proper account.

- 2. Automatic Payment through your Bank: Some homeowners choose to set up an automatic debit, "Bill Pay," through their personal bank. Please make sure to update the payment mailing address to the address noted above.
- **3. On-line Payment through PayLease:** The online payment site will enable you to make a payment using an electronic check, debit or credit card. Simply visit www.abeva.com or www.PayLease.com and select Make a Payment. You can make a one-time payment or setup to pay annually. Please note, a convenience fee is applied when using this payment method.

What Does ABEVA Do?

Arizona Biltmore Estates Village Association (ABEVA) is the Master Homeowners Association for residential properties, apartment communities and certain commercial properties located in the Biltmore area. There are 15 individual residential communities, each of which have their own subassociation (HOA) and are generally managed by professional firms. Commercial properties include the Arizona Biltmore Resort and several office complexes located along Arizona Biltmore Circle and 24th Street and 24th Parkway.

There are 32 "Grandfathered" residences located on Thunderbird Trail and Biltmore Estates Drive that are not members and are exempt from Control by ABEVA CC&Rs. **SERVICES:**

ABEVA provides landscaping, streetlight and street maintenance for common areas located outside the individual communities, except for Thunderbird Trail from 24th Street to the hotel entrance, which is the responsibility of the hotel. ABEVA installed and maintains 70 streetlights along common area roads.

A twenty-four hour roving patrol covering all areas including individual communities are provided. Incident reports are sent to the community managers. This service is currently under contract with Transcend Security Services.

Architectural and landscaping control for all areas outside individual communities are the responsibility of the Architectural Committee of the Board of Directors.

ABEVA is responsible for enforcement of rules and regulations established pursuant to provisions contained in the Declaration of Covenants, Conditions and Restrictions.

FINANCES:

The primary source of revenue is annual assessments from each of the residential homeowners. There are 1,688 homeowners, and the annual assessment is paid







November 1st, the beginning of each fiscal year. The current rate is \$275 which covers operating expenses and additions to a reserve fund for future major repairs and capital additions. In addition, ABEVA receives annual assessments from the various commercial properties and two condominium communities, Fairway Lodge and Two Biltmore Estates, to cover the cost of maintaining the common areas.

Operating budgets are prepared annually by the Director and Treasurer as the basis for establishing annual assessment rates. The budget is reviewed by the Budget Committee of the Board and approved by the full Board. Approval by the homeowners is not required.


